# HOMILY – Fourteenth Sunday in Ordinary Time – Cycle C Isaiah 66:10-14c Gal 6:14-18 Luke 10:1-12, 17-20

"Peace! Peace be to you!...Let the peace of Christ control your hearts, let the word of God dwell in you richly." As we celebrate our nation's birth this weekend – our freedoms and our blessings as a country and individually - it is appropriate that our focus be on peace. Especially at a time when there is so much acrimony and distrust, so much violence and hatred, so much competition and contention. Jesus calls us in our gospel to bring peace to all those we encounter. We are to be the peacemakers by allowing God's Word – his truth – to dwell within us so deeply that it controls our hearts in every way. We are



called in a special way to be the carriers of peace out to a world beset by violence, hatred and acrimony. Let me share a couple key thoughts about this in the short time I have. First, we must always and everywhere defend the sanctity of human life from conception to natural death. The peace, truth, and love of Jesus are not consistent with the violence of abortion. Life is sacred! The over sixty million children taken from us by abortion cry out for justice and peace. We as a nation have become desensitized to what abortion is. Many are repulsed by abortion, but have come to see it as a necessary evil.

We as Catholics in particular, need to work to remove the circumstances which make abortion appear to be necessary; and expose it for the evil it is! We need to replace the violence of abortion with the peace and hope of life. In his encyclical, *The Gospel of Life*, St Pope John Paul II challenges us to assess our efforts saying, "With great openness and courage, we need to question how widespread is the culture of life today... With equal clarity and determination, we must identify the steps we are called to take in order to serve life in all its truth." He tells us *The Gospel of Life* is at the heart of Jesus's saving message to the world. It is the peace and truth we are called to give voice to. As the discussion of the abortion issue returns to the states, we need to enter into dialogue to foster a *Culture of Life* to change hearts and minds. Pope Francis challenges us to make our parishes "islands of mercy in the midst of a sea of indifference." They should become sanctuaries of peace for *Moms in Need*!

<u>We need to recognize the constancy</u> which exists at the very center of every abortion. Abortions are performed for a variety of reasons, ranging from pure convenience to rape and incest. But no matter the circumstances leading up to an abortion, <u>every abortion involves both a child and a woman.</u> Our best defense for the children is to help the mothers see past their crisis of the moment, to a life of hopefulness and potential, for both themselves and their child. <u>We must defend, protect and value both lives with the passion of Christ,</u> seeing in each the image and presence of God himself.

We have much work to do in creating a *Culture of Life*. It starts by better understanding the challenges which lead women to consider abortion as an option. So often, women do so because no other viable options seem apparent. A pregnancy can bring chaos and fear when unwanted or unexpected. A woman may be faced with overwhelming financial and / or emotional challenges. This is particularly true for the poor and those who have no family support system. In SVdP, we see the consequences of these circumstances with regularity. Others may feel their careers or life plans are suddenly in jeopardy. We cannot ignore these challenges or set them to the side. They are real struggles; and women can find hope and joy for the future being quickly drained from their lives.

Jesus is sending us as His disciples, with His message of Good News to share. It is His values we are called to uphold and promote, His spirit of mercy and compassion and forgiveness we are called to communicate. The more we do, the more we come to know Him, and the more deeply we allow Him to live within us, the more powerful and life changing will be our presence in the lives of those we encounter, in our families and in our communities.

Let us be nourished and fueled by the Eucharist, guided by prayer, and graced with the *Joy of the Gospel*, as we strive to touch the hearts of those confronted with abortion that they may embrace life over death. The peace of Christ to each of you and your household!

I know that lives will be saved, changed, and healed when it is released. I am beyond grateful that God provided this opportunity for me to be a part of this life saving film.
