# **ABORTION PILL RISK TO WATER SUPPLY?**

A group of Republican lawmakers questioned the Biden administration about the possible risk to the country's water supply caused by chemical abortion-inducing drugs.

Led by Senator Marco Rubio, the group wrote a letter to the Environmental Protection Agency that stated: "Given the steadily increasing rate of at-home chemical abortions, it is vital that the EPA ensure mifepristone, the drug's active metabolites in blood and placenta tissue, and the fetal remains of unborn children — all of which are unbelievably being flushed into America's wastewater system — do not pose a threat to the health and safety of humans and wildlife."

Their concern was that the impact of the drug to the water supply has not been sufficiently studied and the American people deserve to know this impact. No report on the EPA's response.

## **DEMOCRATIC PARTY'S WOMENS HEALTH PLAN**

Casey has suggested that "pro-life" never meant a complete ban on abortion without exception, at least to him. ... Casey supported Democrats' legislation to keep abortion legal to the Roe v. Wade standard of barring abortion only after viability, around 24 weeks. [emphasis added]

"Everyone in the Senate had a choice to make," Casey told The Associated Press. "You had to decide, basically, whether you'd support banning abortion or not. And that was a choice you had to make. And the choice was also a choice about legislation. ... And I decided that I would support advancing that bill and thereby not being in the ban-abortion column."

### **POPULATION DECLINE**

The miracle of life impacts not only the mother but the whole of society. Babies radiate and generate joy.

Fr. Shenan Bouqet states: "Older folks sometimes feel as if they have become ten years younger when they first learn that they are to become grandparents. Suddenly, it is not just the decline of old age that they have to look forward to, but rather the love that they can shower upon a grandchild, and a kind of re-living of their own years of youth and parenthood (but without all the responsibility!). Such is the joy that a baby can bring. And such, it seems, is the joy on which our entire civilization has turned its back."

In the United States, the birth rate has fallen to its lowest rate in history. The CDC found that in 2023 the overall fertility rate fell to just over 1.6 babies born per woman, well below the replacement rate of 2.1.

Couples attempt to balance pursuing their own personal and professional ambitions and providing opportunities and experiences for their children. In this attempted balancing act, the children lose.

In the name of feminism, governments poured billions of dollars into promoting abortion, contraception and sterilization. As long as this anti-life mentality continues, the birth rate will continue to decline.

## **SAFE HAVEN BABY BOXES**

Parents can anonymously and safely leave in "Safe Haven Baby Boxes" an infant they are unable or unwilling to care for. The aim is to prevent abandonment and ensure infants are placed in proper care. The process involves opening the box's secure door, placing the baby inside, and then closing the door. Once the door is shut, a sensor alerts authorities to retrieve the baby.

In the Lehigh Valley, Safe Haven Boxes are located at St. Luke's and Lehigh Valley Hospitals.
